- **All portable or temporary above ground pools must be permitted and comply with the regulations listed in North Cornwall Township Zoning Ordinance #295, Article 3, Section 319.R.5, Residential Swimming Pools.**
- **Portable pools with electrical filtration pumps must be inspected by a Township official. Please call to arrange the inspection.**
- **Position the pool on property so that it can be plugged directly into a GFI outlet at the rear of the house. Use of extension cords from the house to the pool is illegal.**
- **Temporary pools must comply with the applicable requirements of Appendix G of the International Residential Code - Swimming Pools, Spas, and Hot Tubs.**
- **Pools must meet required setbacks, as well as be positioned in an area that prevents splashing/discharge of water beyond property line and onto neighboring properties.**
- **Water must be dechlorinated prior to draining the pool and disassembling it at the end of the season.**
- **Temporary pool permit annual fee: \$50.00**

*Failure to comply with the annual submission of a Temporary Pool Permit Application and required regulations may result in revoking this permit, sending Township Notice of Violation, which charges a \$85.00 administrative and inspection fee, per every notice, or any other penalties and fees as outlined in Ordinance #295.*
